<u>History Development of Marsh Harbour and its business infrastructure,</u>
government offices etc.

The first real settlers in Abaco were British Loyalists. They came to Abaco in the 1780's during the American Revolutionary War. Marsh Harbour is centrally located and it was found in 1784 and is the largest and center of commence.

Mars'n Harbour, the capital of Abaco, seems to have been a bi-racial settlement. Settlers, including whites, free blacks, and slaves from the first loyalist villages of Carleton and Maxwell Town made their homes at Mars'n Harbour. The latter had a safer harbor though not so deep. By 1785 44% of the population of Abaco lived at Mars'n Harbour.

Mainly the whites developed Marsh Harbour because they were the ones with the money at the time. They also began growing sisal in the late nineteenth century. Because of a terrible hurricane in 1932, the free blacks who lived in the other settlements in the north were forced to move closer to marsh Harbour. After this occurred, the government provided an agricultural officer to promote the development of farming. Produce was intended for local consumption with the surplus being sold in Marsh Harbour. This is what began the development of Marsh Harbour.

Marsh Harbour is the largest settlement and the seat of government — all Government Offices are located here. It is also a major business center and a Port of Entry. It is the third largest town in the Bahamas, the largest being Nassau and the second largest Freeport, Grand Bahama. The harbor at Marsh Harbour is just as spacious as Nassau is, but it cannot accommodate deep draft vessels. However, there is a constant flow of small boat traffic in the harbor as Marsh Harbour is home to several Marinas; The Bahamas Yachting Service is the largest in the Bahamas. Marsh Harbour also boasts an International Airport, supermarkets, and liquor and hardware stores. Also it entails many restaurants, marinas and other businesses. There is a medical clinic, Post Office and the Offices of the Senior Administrator fir the Island. There are also a number of hotels and guest houses in Marsh Harbour.

One of the major reasons why Marsh Harbour is the Central Business District of Abaco is because like I said earlier, "the whites were the ones with the money at the time." Most of them lived in Marsh Harbour and some still do; so they wanted to build there businesses closer to home. At that time it made more sense. It was very difficult for those persons living further out.

Abaco is seen as the boat building capital of the Bahamas. This was a skill passed on by the Loyalists and kept alive by the Abaconians. Boat building was done in Marsh Harbour as well as some of the other settlements. Fishery was another small business done within Marsh Harbour using the boats made. The biggest investment made in Marsh Harbour lately was the development of the Port.

The businesses within Marsh Harbour began on a minor scale and later maximized throughout the years. The first gas station was owned by an Abaconian and later sold to another. During the course of the time, the growth of the other two gas stations, owned by the Albury brothers (Texaco and Shell), increased tremendously. There were a variety of services offered at both gas stations such as: an oil change, a tire repair, and many more.

Bertrum Mills, Mr. Swain, and Captain Percy Archer were all businessmen who invested well in their business by expanding the building spaces. In doing this, it allowed them to offer a vacant room where persons, wanting to start a business, could operate from. These men each benefited from this because these tenants would have to pay rent in order to operate there. This mainly occurred in the downtown area of Marsh Harbour.

After a while, Marsh Harbour became more developed because later when the tenants' business got off to a good start, they would be able to afford their own piece of property to manage their own businesses within the Marsh Harbour area.

Because of all the investments made, blocks of buildings were produced such as: The B and V Plaza (owned by Bertrum Mills) and The Percy Archer Square. These buildings still exist today.

As I have stated earlier there are a few government offices located in Marsh Harbour, but none of them are located in government buildings. The only government office that operates in its own building is BTC.

The rapid growth of Abaco has been well acknowledged by the government of the Bahamas. Also, plans have been drawn up showing the enlargement of some buildings.

Other businesses and Banks are based "within a stones throw" to one another. The roads are well kept and are easily approached. Traffic is also governable and allows effortless use for both pedestrians and motorists.

In having new investments opportunities and investors along with the attainability of land, the future development of Marsh Harbour seems very brilliant.

First of all, I am going to start off by giving the meaning of that statement. It simply means what do all of the businesses have in common and what is its surrounding area like.

What most of these buildings have in common are that they all basically do not own the buildings in which they operate. Instead, they rent from the business men who built these blocks so that persons may rent from them. Also, a lot of them end up in the same business (i.e. selling clothing). Some persons just do not have any imagination to come up with a business

The environment is simple it is all congested. Everything is all in one when I say that I mean all of the building blocks are side by side or maybe across the road from one another. There are not enough varieties of places to shop from everything are basically the same.

The main shopping centre of Abaco is in Marsh Harbour. Marsh Harbour has everything from banks to schools, food stores and hotels. It's amazing how much it has to offer.

Most persons live around the area so it is much easier for them to do their personal shopping but persons living in the north and south have to travel for almost an hour just to get to Marsh Harbour. Construction workers have to come from far and near to do their banking on Fridays. It is necessary for them to come to Marsh Harbour to do there grocery shopping because in the their settlements there are only convenience stores. The necessities that they look for can sometimes only be found in Marsh Harbour.

Like I said in the beginning mostly clothes are sold in basically every other shop. Then you can also find jewelry, shoes and a lot more. Some of the stores are MJ's Fashion, Sports World, and Roselyn.

Analysis/Conclusion

The writer will conclude by saying that Marsh Harbour is the Central Business District of Abaco because it contains basically everything from stores to hotels and many. It so happens, that Marsh Harbour became this way after the loyalist started it up.

Also, the analysis shows that Marsh Harbour is well developed since the 1970's and that Marsh Harbour is growing to a great extent.
