Legislations

Data Protection Act 1998

The Data Protection Act 1998 is enforced for anyone processing personal data must comply with the eight enforceable principles of good practice. They say that the data must be:

- Fairly and lawfully processed
- Processed for limited purposes

- Adequate, relevant and not excessive
- Accurate
- Not kept longer than necessary
- Processed in accordance with the data subject's rights
- Secure
- Not transferred to countries without adequate protection

Personal data covers both facts and opinions about the individual. It also includes information regarding the intentions of the data controller towards the individual, although in some limited circumstances exemptions will apply. With processing, the definition is far wider than before. For example, it incorporates the concepts of 'obtaining', holding' and 'disclo sing'.

Computer Misuse Act 1990

The computer misuse act in a nutshell is a legislation that a law for any persons that is guilty of an offence if he does any act which causes an unauthorised modification of the contents of any computer and at the time when he does the act he has the requisite intent and the requisite knowledge.
