Second Amendment

For the last few thousand years, weapons had scared the world history with hundreds not to say thousands of wars and slaughter of human being. People are to kill or be killed. In the *Right to Keep and Bear Arms*, "Every ablebodied freeman, between the ages of 16 and 50, was enrolled in the militia...the law requires every militia man to provide himself with the arms usual in the regular service," continues "bearing arms to defend the community was considered a duty of property owing men." (*The right to gear arms: Crimes.org*) The law was provided at first to the

militia revolutionists when fighting against English government during the war. It was later for the aftershock of revolting which possess the American to have this origin law to grave into the Bill of Right, if not for the citizens to protect themselves when England invade. Clearly the law was written for the sake of protecting the citizens and militia services, but holds the opposite for today's society. In each state's provisions, the law is stated to be given not to individual reasons but for the protection of self and the state. As written in the provision of Alabama, "That the great, general and essential principles of liberty and free government may be recognized and established, we declare.....that every citizen has a right to bear arms in defense of himself and the state." However, due to the advancements and evolution, situation shifted have from the protection of self to chaos.

In the twentieth century of today, crime rates are sky high compared to criminal records of the past. The 2001 statistics estimated the number of 79 percent homicide rate, with 66.1 percent of 1985. There has been an 14 percent increment during the past 16 years. What happened during this 16 year period? Not only did the percentage of crime increased, the number of artillery and guns also increased. This new inventory of weapon aided criminals to have a higher rate of success on whatever their goal to was, to rob or kill. These new weapons promised definite accuracy, and the damages made by these guns or rifles are surely menacing. How can the government assure that the damage will not be upon us?

Because of the 2nd amendment, citizens have the right to bear arms with in the household and their properties. Neighbors have great chance of being shot or their life

The old man offered the space across the table. They started eating and gossiping about the political parties with in the government, the old man opposed the young man's political party. Arguments began, the young man is frustrated by the old man's oppositions and they started fighting. The young man slipped out his gun during the quell and shot 6 bullets into the old man's chest. Certainly, the elder died, and the young man was arrested for felony.

Few days later the young man was only charged with second degree because he was supposedly defending himself. The victim's relatives raved, and question the judge in anger for his conclusion. Because of the second amendments for the right to bear arms, the suspect had armed himself and was not being accused of 1st degree murder.
